**ARTICLES OF INCORPORATION  
OF  
PAID SEARCH ASSOCIATION, INC.**

The undersigned, acting as incorporator of this Corporation not-for-profit pursuant to Chapter 617, Florida Statutes, adopts these Articles of Incorporation as follows:

**ARTICLE I  
NAME**

The name of this Corporation is PAID SEARCH ASSOCIATION, INC. The initial address of the corporation is 12130 Randee Road, New Port Richey, Florida 34654.

**ARTICLE II  
DURATION**

The period of the duration of this Corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

**ARTICLE III  
PURPOSE**

The purposes for which this Corporation are organized are exclusively non-profit and for the purpose of transacting any and all business for which corporations may be formed under Chapter 617 of the Florida Statutes, as amended from time to time.

**ARTICLE IV  
MEMBERS**

The members of the Corporation shall be as provided in the by-laws.

**ARTICLE V  
REGISTERED AGENT**

The name and street address of the initial registered agent of this corporation shall be: Alan B. Cohn, Esq., 200 East Broward Blvd., Suite 1800, Fort Lauderdale, Florida 33301.

**ARTICLE VI  
BOARD OF DIRECTORS AND OFFICERS**

The number of persons constituting the Board of Directors of the Corporation shall be not less than three nor more than fifteen as provided in the by-laws. The membership of the Board of Directors and the manner of their selection shall be provided in the by-laws. The names and

#### **ARTICLE VII**

##### **INDEMNIFICATION OF OFFICERS AND DIRECTORS**

All officers and directors of this Corporation shall be indemnified by the Corporation as provided in the by-laws against all expenses and liabilities, including attorney's fees (including appellate proceedings) reasonably incurred in connection with any proceeding or settlement thereof in which they may become involved by reason of holding such office. The Corporation may purchase and maintain insurance on behalf of all officers and directors against any liability asserted against them or incurred by them in their capacity as officers and directors or arising out of their status as such.

#### **ARTICLE VIII**

##### **NON-STOCK BASIS**

This Corporation is organized on a non-stock basis.

#### **ARTICLE IX**

##### **DISSOLUTION**

The Corporation shall dissolve with the winding up of its affairs as provided in the by-laws.

#### **ARTICLE X**

##### **NON-PROFIT STATUS**

This organization is organized not-for-profit and is not intended to be nor is it organized for the purpose of engaging in any activity ordinarily carried on for profit. No part of the net earnings of this Corporation will inure to the benefit of any member or other individual. The Corporation shall be primarily supported from activities substantially related to its tax exempt purpose.

**ARTICLE XI  
AMENDMENT**


This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto.
