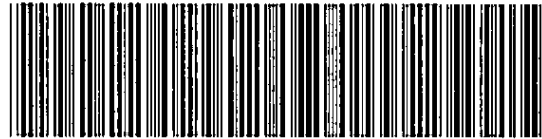

The undersigned, acting as the incorporator of a not for profit corporation under the laws of the State of Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I: NAME

The name of the corporation shall be **The Bre Effect Foundation, Inc.** hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office is 8004 NW 154<sup>th</sup> Street, Suite 647, Miami Lakes, Florida 33016.

ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSE
