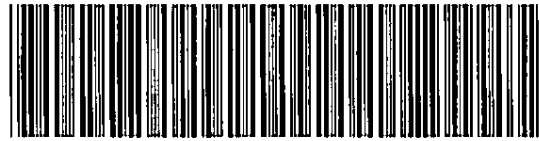

# ARTICLES OF INCORPORATION

## LUKE 14 EXCHANGE, INC.

(Not for Profit Corporation)

### ARTICLE I NAME

The name of the corporation shall be *Luke 14 Exchange, Inc.*

### ARTICLE II PRINCIPAL OFFICE

The principal office and of the corporation shall be *2752 Canyon Crest Drive, Lakeland, FL 33811*. The mailing address of the Corporation shall be *3616 Harden Blvd., #163, Lakeland, FL 33803*.

### ARTICLE III PURPOSE

This corporation is organized exclusively for such nonprofit, charitable and/or educational purposes, and such other purposes *as will qualify the corporation as an exempt organization under section 501(c)(3) of the Internal Revenue Code*, or corresponding section of any future federal tax code. The corporation is a Christian organization whose purpose is to encourage and build up individuals with disabilities, their families and the those impacted by disability in their unique calling through mentoring, coaching of mentors and working together with Christian communities to identify job and service opportunities and challenges unique to the disability community.

### ARTICLE IV NOT FOR PROFIT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.






