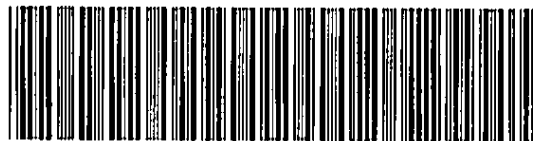

Article I – Name

The name of the Corporation shall be Florida Families, Inc.

Article II – Principal Office

Article III - Purpose

The specific purpose for which this Corporation is organized is to provide a cooperative, problem solving and supportive environment for parents and families who are contemplating adversarial divorce.

This Corporation recognizes that divorce can often be a destructive experience for many parents and their families. Parents who seek divorce by petitioning the family courts will often do so hastily and without due regard for the danger and risk involved. Factors such as abusive behavior, mental health issues, and addiction may not be adequately considered by families during the course of an adversarial divorce. Further, the Corporation believes that many marriages which end in divorce can be rehabilitated. With these considerations in mind, the Corporation will seek to assist parents and their families to work through their core familial issues with the intention of helping these families find peaceful resolution without having to resort to destructive litigation. Further, the Corporation will endeavor, from time to time, to host educational seminars and provide information and demonstrations to the general public on the benefits of cooperative dispute resolution in lieu of adversarial divorce.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or

corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
