## ARTICLES OF INCORPORATION OF

FIND YOUR PEACE BY PIECES, INC. a Florida not-for-profit corporation in compliance with Chapter 617, F.S.

#### ARTICLE I.

Name

The name of this Corporation shall be FIND YOUR PEACE BY PIECES, INC.

ARTICLE II.

Duration

The duration of this Corporation is perpetual.

#### ARTICLE III.

Purpose

The purposes of the Corporation shall be exclusively charitable in nature, to-wit: To engage exclusively in activities for charitable or educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), and within these restrictions, to engage in activities including but not limited to the following:

- (a) To receive contributions and use them for charitable or educational purposes including but not limited to providing space for groups in Wellness Center. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the (including the publishing or distribution of candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code).
- (b) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its trustces, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.
- (c) Upon the dissolution of the Corporation the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), as the Board of Directors shall determine.
