

Article I: **Bayshore Watch, Inc.** is the name of the Not for Profit Corporation

Article II: The **principal place of business of Bayshore Watch, Inc** is 410 Bryn Mawr Island, Bradenton, Florida 34207. The mailing address is P.O Box 5647, Bradenton, FL 34281-5647.

Article III: The mission of **Bayshore Watch, Inc.** is to provide actions to complement, sustain and improve the lifestyle of residents of Bayshore Gardens Subdivision and nearby areas. These actions include neighborhood safety, information gathering/analysis, assisting in concert with Homeland Security/FEMA supported Community Emergency Response Team (CERT) and fund-raising in support of activities that benefit the community.






