The number of Directors elected by the Members subsequent to the "Master Declarant's Resignation Event" (as hereinafter defined) shall be an odd number of no-more than seven (7). The Cassia at Skye Ranch Neighborhood Members shall elect four (4) Directors and the Esplanade at Skye Ranch Neighborhood Members shall elect three (3) Directors. The Board shall determine the number of Directors to comprise the Board from time to time. Except for Master Declarant-appointed Directors, Directors must be Members or the parents, children or spouses or officers or directors of Members. There shall be only one (1) vote for each Director.
