

ARTICLES OF INCORPORATION
OF
Freedom To Grow, INC.

- ONE: The name and address of this principal corporation is Freedom To Grow, Inc., 956 West Hal McRae Blvd. Avon Park, FL 33825. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO: This Corporation is non-profit corporation organized under the State of Florida Non-profit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under the law. The programs will consist of Empowerment & Self Help including but, shall not be limited to: Disadvantaged Youths & Families, Literacy, Mentoring, Healthcare, Job Training, Counseling, Elderly Care, and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

- (a) The Corporation is organized exclusively for charitable, religious, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on by: (1) by a corporation exempt from federal income tax under Section 501(c)(3) or by a corporation contribution to which are deductible under Section 170(c)(2) of the Internal the Internal Revenue Code.


SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

SEVEN: The property of this corporation is irrevocably dedicated for charitable, religious, educational and scientific purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for religious, charitable, educational and/or scientific purposes as defined under Section 501(c)(3) of The Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the appropriate Court in the county in which the principal office of the organization is located, exclusive for such purposes or to such or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
