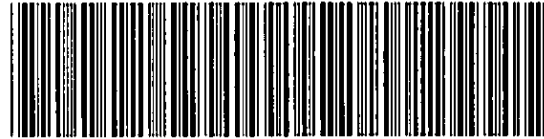

Article III of the Articles of Incorporation form is amended to read as follows: This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely : To promote the spiritual, psychological, emotional, social and material well-being of ex-convicts, parolees, incarcerated persons and ex-offenders in our area. Such assistance will include (but not be limited to) Christian ministry, spiritual counseling, inspirational events, individual educational enrichment sessions, home visitations, marriage and family interventions, employment referrals and other helpful activities to encourage the aforementioned persons and their families to become whole and reintegrated to the community. This organization will share the hope we have in Jesus Christ and make manifest the fruits of the holy spirit in the lives of those who need it the most. It will implement seminars, courses, lectures and events to raise awareness about the importance of dealing compassionately with all members of the community. In all its actions, this corporation will strive to lessen neighborhood tensions, provide assistance young people and at risk persons , while combating recidivism and community deterioration. This organization will establish and maintain a Church wherein all people who sincerely seek God's love will be welcomed without hesitation or intolerance. Said Church is empowered to provide any resource required for worship, religious education and ministry to the community. It is empowered to provide a parsonage for the Pastor and his family including appropriate furnishings for the sanctuary and the home. The pastor is the incorporator, Pernon Thomas who has been appointed according the Christian faith and the Holy Spirit. He is the sole and final authority in matters of the Christian faith, including the sole prerogative to determine which issues pertain to the Christian faith and require his decision. The Pastor, directors and officers of this corporation are empowered to carry any other actions which are deemed by them to be conducive to the attainment of the aforementioned goals and objectives. This organization will carry on the Great Commission stated in Matt 25:36 "I was naked and you clothed Me; I was sick and you visited Me; I was in prison and you came to Me."

In the event of this corporation's dissolution, the directors will --after settling all debts and liabilities-- distribute any remaining cash or assets to other charitable corporations that are recognized as such by the IRS under section 501(c)(3) of the IRC and that have goals similar to those of Hands of Hope Helps Ministries Inc.
