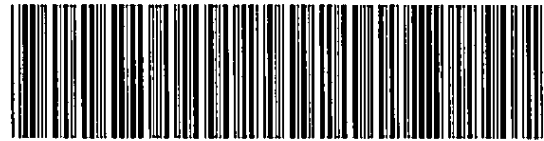

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which The Yvonne Bell Foundation, Inc. is organized is to provide a place where families faced with tough health issues can indulge in a healthy, wholesome, fun environment to be strengthened in the midst of going through a difficult time. The corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed: The initial Board of Directors has been appointed by the President and CEO. Future Board of Directors to be selected via annual elections, after nominees are determined through the review board selection process. Future vacancies are to be filled by appointment of the President and CEO, as deemed necessary or until elections can be held. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively used for the nonprofit purposes and shall distribute the remaining assets of the Corporation to such organization or organizations which are tax exempt under section 501(c)(3) of the Internal Revenue Code, as the Board of Directors in its sole discretion shall determine.
