WINDSOR AT CELEBRATION INDEPENDENT LIVING RESIDENTS ASSOCIATION CORP.

Article III; Purpose:

The Corporation is organized and shall be operated on a not-for-profit basis and exclusively for social welfare within the meaning of Section 501 (c) (4) of the Internal Revenue Code (or the corresponding provisions of any future United States federal tax law). The specific purposes of this corporation are: to improve the quality of life for all resident members in Independent Living of Windsor at Celebration by representing resident members on resolving problems and recommending changes in policies of common concern to all residents. To establish committees to carry out activities of benefit to resident members. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax exempt status under Section 501(c)(4).
