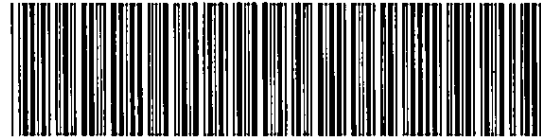

# **ARTICLES OF INCORPORATION FOR SEEDS FOR PIU, INC.**

In compliance with Chapter 617, F.S., (Not for Profit)

## **ARTICLE I: NAME**

The name of this corporation shall be SEEDS for PIU, Inc.

## **ARTICLE II: PRINCIPAL OFFICE**

The principal street address, and mailing address, is 527 NW 97th Ave, Plantation, FL 33324

## **ARTICLE III: PURPOSE**

The corporation is organized to function as a missionary arm of the Church of Jesus Christ by facilitating outreach, spiritual formation, Christian education, holistic development, discipleship, worship, and other ecclesiastical activities.

## **ARTICLE IV: VOTING**

The affairs and business of the corporation shall be managed by its Board of Directors. The Board members ("Directors") shall appoint from among themselves the officers needed to fulfill the legal obligations of a Florida nonprofit corporation, and others officers as deemed necessary. Each Board member shall be entitled to one vote on each matter submitted to a vote of the Board. There shall be between three and five members of the Board of Directors, each of whom shall be appointed by a majority vote of existing Board members. The initial Board of Directors shall be appointed by the Incorporator. To be qualified for the office of Director a person must be at least 18 years of age. Each Director shall personally affirm all points of the above purpose statements and must agree to abide in all respects with corporate policy.
