ARTICLES OF INCORPORATION OF OUR LADY'S TRIDENTINE MASS SOCIETY, INC.

We, the undersigned, desiring to form a non-profit corporation for religious and charitable purposes in accordance with Chapter 617 Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Our Lady's Tridentine Mass Society, Inc.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 507 South Prospect Avenue.

Clearwater, Florida 33756. The mailing address is the same.

ARTICLE III - DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV - PURPOSES

As a canonical society erected by the Bishop of the Catholic Diocese of St. Petersburg. Florida, this corporation is formed for the following purposes:

- 1. Fostering the holiness of its members.
- Promoting public worship according to the Extraordinary Form of the Roman Rite provided for by Pope Benedict XVI in the Motu Proprio, Summorum Pontificum (July 7, 2007).
- 3. Exercising other works of the apostolate, such as initiatives of evangelization, works of piety or charity, and those which animate the temporal order with a Christian spirit.

ARTICLE V – DIRECTORS/TRUSTEES

The manner in which the directors/trustees are elected or appointed shall be as stated in the statutes and bylaws of the corporation. The number of directors/trustees shall not be less than three. The names and addresses of the persons who are to serve as initial directors/trustees until their successors are elected, are:

<u>ARTICLE VIII – POWERS</u>

The corporation shall be empowered to perform all acts allowed by the laws of the State of Florida to a corporation not-for-profit under Chapter 617. Florida Statutes.

ARTICLE IX - LIMITATION OF PURPOSES AND ACTIVITIES

Notwithstanding any other provision of these Articles, this corporation will not have any purposes nor carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

<u>ARTICLE X - DISSOLUTION</u>

In the event of the dissolution of the corporation, its assets shall be distributed (giving priority to the Catholic Diocese of St. Petersburg, Florida) for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the Federal Government, or to a

state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes, or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.
