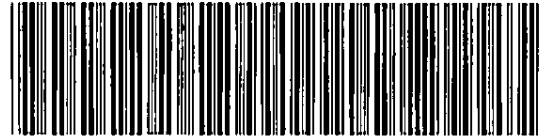



The undersigned, acting as incorporators for this not-for-profit corporation pursuant to Chapter 617 of the Florida Statutes, hereby form a not-for-profit corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be **APOSTOLES SAGRADOS CORAZONES UNIDOS de JESUS y de MARIA, INC.**

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 10 day of June 2019 and shall exist perpetually.

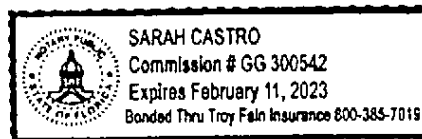
