*Pursuant to the provisions of section 617.0124 Florida Statutes, this document is being submitted within thirty (30) days to correct the Articles of Incorporation of Leaping Gaps, Inc.:*

**FIRST:** These Articles of Correction correct the Articles of Incorporation of LEAPING GAPS, INC. (the "Corporation"), filed with the Florida Department of State on June 24, 2019, and assigned Document Number: N19000006429.

**SECOND:** Article IV omitted the names of the initial members of the Board of Directors of the Corporation.

**THIRD:** Article IV, as amended, shall read as follows:

**"ARTICLE IV
