



Articles of Incorporation Of

Article 1.

The name of the corporation is Oldies But Goodies Chores & More, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 1414 Golfair Blvd. Jacksonville, FL 32209. The initial registered agent of the Corporation at such address shall be: Brandon Evins.

Article 3.


Article 4.
