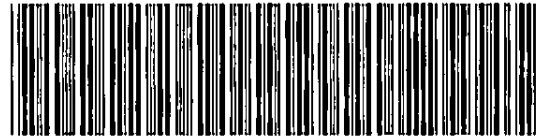



Article VIII – DISSOLUTION OF THIS ORGANIZATION


