# Articles of Incorporation Of

# Welfare Innovation Foundation, Inc.

(In Compliance with Chapter 617, F.S., Not for Profit)

# Article 1.

The name of the corporation is Welfare Innovation Foundation, Inc.

# Article 2.

The initial registered office of the Corporation shall be at: 4534 Amblewood Ct, Pace, FL 32571. The initial registered agent of the Corporation at such address shall be: Purushottam K. Garg.

# Article 3.

The name and address of the incorporator is:

# Article 4.

The initial principal office address of the Corporation shall be at: 4534 Amblewood Ct, Pace, FL 32571.

# Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Specific purpose is to provide medical education and research to medical professionals in order for them to provide sufficient service to people in the communities.

# Article 6.

The Corporation shall have perpetual duration.

Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

# Article 9.

No substantial part of the activities of the corporation shall be carrying on of propaganda, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
