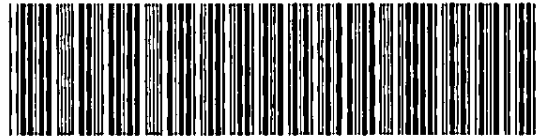

Adding : Article IX This Corporation (Joseph Anthony Machado Foundation Inc.) is organized exclusively for charitable,  
scientific and educational purposes, more specifically to provide advocacy, fundraising and capacity building  
services to Veterans and Veteran organizations, and wellness of people in Florida. To this end the Corporation  
shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Reve.  
as now enacted or hereafter amended (the "Code"), including, for such purposes, the making of distributions to organizations

that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986  
as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or  
shall be devoted to said purposes. In furtherance of such purposes, the Corporation shall have full power and authority:  
Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the  
meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future purpose.  
Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal  
office of the corporation is then located, exclusively for such purposes or to such organization or organizations,  
as said Court shall determine, which are organized and operated exclusively for such purposes."  
No part of the net earnings of the corporations shall inure to the benefit of, or be distributable to its members, trustees,  
officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable  
compensation for services rendered and to make payments and distributions in furtherance of the purposes  
set forth in Article Third hereof."
