# ARTICLES OF INCORPORATION of USARK Florida, Inc.

The undersigned, acting as incorporator of a corporation, pursuant to Chapt \$\overline{\overline{6}}\) 7. Florida Statutes, adopts the following Articles of Incorporation:

#### **ARTICLE I – NAME**

The name of this corporation shall be USARK Florida, Inc.

#### ARTICLE II – PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this Corporation shall be 5120 S. Lakeland Drive, Suite 3, Lakeland, Florida, 33813.

#### ARTICLE III - PURPOSES

The specific purposes for which **USARK Florida**, **Inc.** is organized are:

- a) To exist and operate as a business league within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, (the "Code") and no part of the income or assets if this Corporation shall be distributed to, nor inure to the benefit of, any individual;
- b) To represent the best interests of businesses and individuals who are involved in the ownership, possession, transfer, sale, education, scientific study, conservation and any other legal activity associated with live animals and working with live animals in Florida and beyond;
- c) To develop a local network of animal owners, businesses, educators, and conservationists;
- d) To promote the positive image of animal owners, businesses, educators, and conservationists;
- e) To sponsor programs, including youth programs, scholarships and other charitable endeavors associated with live animals; and

f) To operate, participate in and/or manage any other live animal programs or activities that are not prohibited by law and that do not conflict with the provisions of Section 501(c)(6) of the Code.

#### ARTICLE IV - POWERS

This Corporation shall have and exercise all powers of any corporation not for profit as the same now exist, or may hereafter exist under the laws of the State of Florida. No part of the assets, income or profits of this Corporation shall be distributable to, or inure to the benefit of, its members, directors or officers or any private individual, except that this Corporation shall be authorized and empowered to pay reasonable compensation to its employees for services rendered and to make payments and distributions in the furtherance of the purposes set forth herein. Notwithstanding any other provision hereof, this Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(6) of the Code.

The qualifications of Members and the manner of their admission shall be regulated by the Bylaws.

The Board of Directors shall consist of at least three (3) members, which number may be increased or decreased from time to time by the Members. The initial members of the Board of Directors shall be elected by the Members to serve until the first annual meeting of the Members of this Corporation. Subsequently, the method of election shall be as stated in the Bylaws of this Corporation.

The Board of Directors shall adopt Bylaws for this Corporation and time to time may modify, alter, amend or rescind the same by majority vote of the members of the Board of Directors present at any regular or special meeting or by written consent of all the members of the Board of Directors.

### ARTICLE XII - AMENDMENTS

This Corporation may amend, alter or repeal any provision of these Articles Incorporation in the manner now or hereinafter provided by Florida law.
