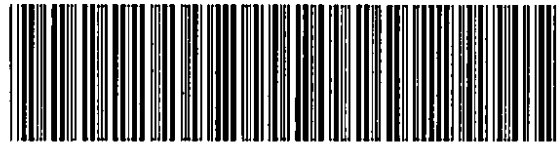

ARTICLES of INCORPORATION
Of

CHURCH WITH PURPOSE, INC.

We, the undersigned, for the purpose of forming a Corporation under, and pursuant to Chapter 617 of the Laws of the State of Florida, do hereby associate as a body corporate and adopt the following Articles of Incorporation.

Article 1

The Name of this Corporation shall be:

CHURCH WITH PURPOSE, INC.

Article 11

The Principal Address of this Corporation is:

Article 111

The Purpose of this Corporation is:

- A. **CHURCH WITH PURPOSE, INC,** is an Evangelistic Ministry that spreads the Gospel of Jesus Christ with the purpose of saving souls for the Kingdom of God with an unwavering message of Repentance of sins and Accepting Jesus Christ as Personal Lord and Savior.
- B. **Founded on the Great Commission of Jesus Christ in Matthew 28:19-20 propagates the Gospel of Jesus Christ throughout the world by means of Evangelistic Ministries, Establishing Churches, Christian Schools, Nursing Homes, Daycare, Bible Studies, Prayer and Fasting, Missionary outreach, Counseling, Distribution of Christian literature, Publish and or Proclaim the gospel through all available media resources. Our sole mission is to seek and to save that which is lost (Luke 18:10)**
- C. **To teach, train and prepare people for an effective life of ministry in the Kingdom of God, Teaching and practicing Love, Faith, Forgiveness, Redemption, Reconciliation, Restoration, Benevolence, and Stewardship as instructed in the Scriptures, and Operating facilities to feed and house the needy. To administer the Biblical Ordinances of the New Testament Scriptures and to Minister to the Spiritual needs of its member and the people in the world, and admonishing that a person must be born-again, that is to experience a spiritual birth.**

- D. To perform Baptisms, Marriages, Conduct Funerals, Ordination and Licensing Believers for the Ministry, Participation in Communions and similar Ceremonies and license of Certificates.**
- E. To receive contribution, gifts, legacies and endowments, consisting of money or other means, or acquisition of other properties from anyone consistent with the purpose of the corporation. To take, secure, accept, build or acquire by gift, purchase, legacy or otherwise real and personal property to expedite in the work and purpose for which this body was organized and to hold, lease, give, exchange or sell and dispose of the same, in part or in whole, when it deems such action necessary in promoting and advancing the work and purposes, for which this corporation is formed. Except as otherwise limited herein, the Corporation shall have all powers necessary and convenient to effect or transact any or all of the business or purpose which the corporation is organized and shall likewise have the powers provided by the Florida Non-Profit Corporation Act.**
- F. The Corporation is formed, organized and operated exclusively for charitable, religious, educational and literary purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501-C-3 of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law, and or Federal Tax Code and qualified foreign mission organizations.**
- G. The Corporation shall not afford pecuniary gain, incidentally or otherwise to its directors, officers, members, trustees or other private persons; no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, members, trustees or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article 111.**

Article 1V

The manner of Election in which the directors are elected and appointed are by the members of this ministry at the annual members meeting at which a quorum of 30% of acting voting age members have been attained. No absentee ballot and or proxy voting are allowed.

- A. The governing of this ministry is vested in the body of members who compose it. Thus the final authority for decisions shall be the congregation to whom the board of directors and staff are responsible.**
- B. Amendments may be adopted to the constitution or bylaws at any annual meeting of the ministries by 75% majority vote of eligible members present, provided proper notice embodying such amendments has been presented, discussed, and adopted by a majority vote at a previous regular business meeting.**
- C. The period of duration of this corporation shall be perpetual.**

Upon the Dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
