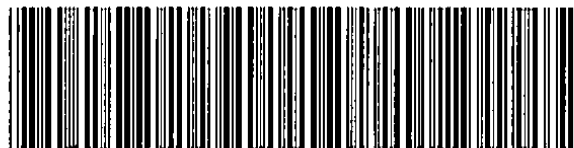

We, the undersigned natural persons, of the age of eighteen years or more, acting as Incorporators of a corporation do adopt the following Articles of Incorporation:

## ARTICLE 1. NAME

The name of this corporation is: NORTHWIND THEOLOGICAL SEMINARY, INC.

## ARTICLE 2. NAME

The principle office address is: 14268 Canarias Dr. Winter Garden, FL 34785

## ARTICLE 3. DURATION

The period of duration for this corporation shall be perpetual or until such time as the Board of Directors shall adopt a resolution recommending that the corporation be dissolved.

## ARTICLE 4. PURPOSES

This corporation is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3). The organization will engage in activities permissible under section 501(c)(3) including: Religious Education. No part of any activities of the organization will include participating in or intervening in any political campaign on behalf of or in opposition to any candidate for public office. This corporation is not organized for profit, and no part of the net earnings of this corporation shall inure to the benefit of any member of the Board of Directors or any other individual except that this corporation may make payments of reasonable compensation for services rendered. The corporation shall never be operated for the primary purpose of carrying on a trade or business for profit. Notwithstanding any provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law).

## ARTICLE 5. MEMBERS

This corporation shall have one class of members as provided in the Bylaws

## ARTICLE 6. STOCK

This corporation shall not have authority to issue capital stock.

## ARTICLE 7. REGISTERED OFFICE AND AGENT


