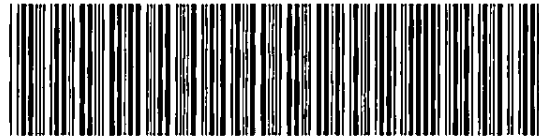

- (a) The SHESPEAKSSOLUTIONS, INC. is a *not-for-profit* corporation, organized to provide and enhance educational opportunities and assistance to diverse, high risk, low-income communities with a primary focus on mental health issues and support resources.
- (b) The corporation will further this purpose through collaboration with other private, public and community organizations to coordinate the acquisition, delivery and distribution of mental health matters, educational resources, food and clothes items to assist the targeted population.
- (c) Notwithstanding the nonprofit nature of the corporation as described in this article, the corporation shall be authorized and empowered and may reimburse its members for actual expense incurred for or on behalf of the corporation as permitted by *Chapter 617*, Florida Statutes, as said Act may be amended from time to time.

**ARTICLE IV – General and Specific Purpose**

- (a) The primary purpose of SHESPEAKSSOLUTIONS, INC. is to:
- i. Provide and enhance educational opportunities and assistance to diverse, high risk and low-income communities with a focus on mental health issues and support resources.
  - ii. Develop mental health programs to heighten awareness of the targeted population through education, training, skill development and other informational and professional sources and resources.
- (b) To make and enforce reasonable rules and regulations governing the operation of the corporation and the use of its assets.
- (c) To operate exclusively in any other manner for such religious, charitable, and educational purposes as will qualify it as an exempt organization under *Section 501(c) (3)* of the Internal Revenue Code of 1986, as amended, or under any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.
- (d) The Corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or the United States for which *not for profit* corporations may be incorporated under *Chapter 617, Florida Statutes*, as amended and supplemented.
- (e) Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

**ARTICLE VIII – Earnings and Assets**

- (a) No part of the net earnings of the SHESPEAKSSOLUTIONS, INC. shall inure to the benefit of, or be distributable to its members, officers or other private persons.

  - i. by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or;
  - ii. by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Tax Code.

**ARTICLE IX - Dissolution**

- (a) The Corporation shall be perpetual. - (b) Any such assets not disposed of shall be disposed of by the Courts of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




