**ARTICLES OF INCORPORATION  
(Not for Profit)  
OF

**Article I – Name**

The name of the Corporation shall be The Future Thinkers, Inc.

**Article II – Address of Corporation**

**Article III - Purpose**

The specific purpose for which this Corporation is organized is to educate young people (ages 18 – 25) on the tools they will need to start a business and become successful entrepreneurs. The Corporation will, among other things, conduct periodic seminars for such youth at schools, community colleges, Indian Reservations, and other venues in furtherance of the aforementioned purposes and objectives.
