

The undersigned, for the purpose of forming a non-profit corporation under the Florida Not For Profit Corporation Act, Florida Statutes Chapter 617, makes and adopts the following articles of incorporation:

Article 1. <u>Name</u>. The name of the corporation is as follows: Ray F. Gottschalk Family Charitable Foundation, Inc.

**Article 2.** <u>Address</u>. The initial address of the principal office and the mailing address of the corporation is physical address is 62 Village Walk, Ponte Vedra Beach, Florida 32082 and mailing address is 62 Village Walk, Ponte Vedra Beach, Florida 32082.

**Article 3.** <u>Initial Registered Office and Agent</u>. The street address of the initial registered office of the corporation is:

Ray F. Gottschalk 62 Village Walk Ponte Vedra Beach, Florida 32082

**Article 4. No Members**. The corporation shall not have members and shall not issue membership certificates. The corporation shall not issue shares of stock.

Article 5. Not For Profit. The corporation is a not-for-profit corporation under Chapter 617, Florida Statutes. The corporation is not formed for pecuniary profit. No part of the net earnings of the corporation shall inure to the benefit of its directors or officers, except to the extent permissible under these Articles, under law and under 26 U.S.C.A. 501(c)(3) (referred to below as "Code"). If the corporation ever has members, no member shall have any vested right, interest or privilege in or to the assets, income or property of the corporation and no part of the income or assets of the corporation shall be distributable to or for the benefit of its members, except to the extent permissible under these Articles, under law and under Code 501 (c) (3).

Article 6. <u>Duration</u>. The duration (term) of the corporation is perpetual.

Article 7. <u>Purposes</u>. The corporation is organized, and shall be operated exclusively for charitable and other exempt purposes within the purposes allowed under Code 501(c)(3), including but not limited to issuing funding grants to assist not-for-profit organizations serving various public needs, veterans, homeless adults and Jacksonville Golf Association and other charities.

- **Article 8.** Powers. Solely for the above purposes, the corporation shall have the following powers:
- **8.1** To research, contact and provide funding assistance related to funding grants to assist not-for-profit organizations serving various public needs, veterans, homeless adults and Jacksonville Golf Association and other charities.
- **8.2** To exercise all rights and powers conferred by the laws of the State of Florida on non-profit corporations, including but not limited to those set forth in Florida Statutes, Chapter 617;
- **8.3** To engage in and transact any other lawful activity, solely in furtherance of the above purposes, for which non-profit corporations may be incorporated under the Florida Not-For-Profit Corporation Act, and any successor or amendment to the Florida Not-For-Profit Corporation Act; and
- **8.4** Do any other things as are incidental to the powers of the corporation or necessary or desirable in order to accomplish the purposes of the corporation.
- **Article 9.** <u>Limitation</u>. No part of the net earnings of the corporation shall inure directly or indirectly to the benefit of or be distributable to its members (if the corporation ever has any), directors or officers, but the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in <u>Article 7 (Purposes)</u> of these Articles.
- Article 10. <u>Tax Exempt Status</u>. It is intended that the corporation shall have and continue to have the status of a corporation that is exempt from federal income taxation pursuant to Code 501(a) as an organization described therein. These articles shall be construed accordingly, and all powers and activities of the corporation shall be limited accordingly. The corporation shall not carry on propaganda or otherwise attempt to influence legislation to such an extent as would result in the loss of exemption under Code 501(c)(3). The corporation will operate in accordance with Code sections 4941, 4942, 4943, 4944 and 4945 of the Internal Revenue Code according to the following:
- **10.1** The corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code or the corresponding section of any future tax code.
- **10.2** The corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future tax code.
- **10.3** The corporation will retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future tax code.

- **10.4** The corporation will not make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future tax code.
- **10.5** The corporation will not make any taxable expenditures as defined in section 4945 of the Internal Revenue Code, or the corresponding section of any future tax code.
- **Article 11. Dissolution**. On the dissolution of the corporation, the board of directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, distribute all of the assets of the corporation exclusively for charitable, scientific or educational purposes in such manner and to such qualified organizations as the board of directors shall determine. Any of the assets not so distributed shall be distributed in accordance with the direction of any court having jurisdiction in the county in which the principal office of the corporation is then located, exclusively for the above purposes of the corporation or to a qualified organization or organizations as the court shall determine. For purposes of this article, an organization is a "qualified organization" only if, at the time of receiving the assets, it is operated exclusively for the purposes described in 26 U.S.C.A. 170(c)(1) or 26 U.S.C.A. 170(c)(2)(8) and is described in 26 U.S.C.A 509(a)(1), (2) or (3).

**Article 12. Board of Directors**. There shall be a board of directors consisting of at least three individuals. The initial directors are elected by the incorporators. After that, each director shall be elected by majority vote of the board of directors in the manner and at the times set forth in by-laws. Any director may be removed by the affirmative vote of at least two-thirds of the board of directors. The initial directors of the corporation are as follows:
