ARTICLES OF INCORPORATION OF DISASTER RELIEF CENTERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the Corporation is DISASTER RELIEF CENTERS, INC.

ARTICLE II PRINCIPAL OFFICE

The principal street address of the principal office and place of business is:

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized is to globally share the Gospel of Jesus Christ to meet the needs of youth and underserved communities by means of mentoring, charitable services, including building community service and disaster relief centers, providing education services, distribution of food and disaster relief supplies through diverse forms of religious and humanitarian faith-based ministry.

No substantial part of the activities of this organization shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Internal Revenue Code, and the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE IX PROPERTY

The property of this organization is irrevocable dedicated to religious purposes. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its directors, officers, members, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

ARTICLE X EFFECTIVE DATE OF FILING

The effective date of filing shall be August 3, 2019

ARTICLE XI DISSOLUTION OF THE ORGANIZATION

Upon the dissolution of the organization, assets remaining after payment, or provision for payment, of all debts and liabilities of this organization, shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a nonprofit fund, foundation or organization which is organized and operated for religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
