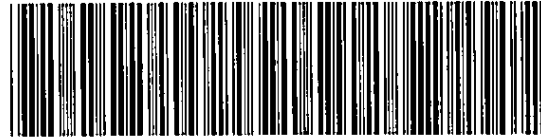

The following is placed at the end of article III: This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely : To establish and maintain a House of Orthodox Jewish Worship according to Sephardic Eastern tradition and there to provide religious, educational, cultural, social and all other activities according to Torah-Halachic practices set forth in the Code of Jewish Law (Shulchan Aruch) by Rabbi Yosef Karo along with the subsequent commentaries and the contemporary responsa of the Sephardic Eastern Sages, all as understood by the synagogue's Rabbi and incorporator, Rabbi Izhak Lasry. It will be empowered to pay salaries, and as well as rent or buy personal or real property, to provide a place of worship as well as a parsonage for the Rabbi and his family.

The Rabbi is appointed according to Jewish Law. He is the spiritual head of the organization and the final authority in all matters pertaining to Jewish Law, including the sole authority to determine which questions or issues are to be considered matters of Jewish Law and require his decision.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation or support political candidates in any way. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered and make purchases of goods or services that are in furtherance of its exempt purposes. This corporation is empowered to supply all the resources, religious items and physical constructions/properties required according to Orthodox Jewish Law, including but not limited to, religious articles, kosher food, ritual immersion pools or transportation to any event or location which in the view of the Rabbi or directors is required for the fulfillment of the organization's mission.

In the event of the dissolution of this corporation, the directors will --after clearing all debts--distribute any remaining assets to one or more charitable organizations recognized by the IRS under section 501(c)(3) that have similar exempt purposes.
