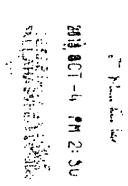

Amendment to Article III PURPOSE:
ARTICLE III, Sec. 1: The purpose for which the corporations is organized is Fetch Life Incorporated is a non-profit entity
dedicated to improving the lives of dogs through supporting rescue dog awareness, acting as adoption ambassadors,
providing shelter dog assistance, and promoting the benefits of canines via education.
ARTICLE III, Sec. 2: Fetch Life Incorporated is organized exclusively for charitable, educational, and scientific
purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations
under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
No part of the net earnings of Fetch Life Incorporated shall inure to the benefit of, or be distributable to its members.
trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonab
compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the
purpose clause hereof.
ARTICLE III. Sec. 3: Upon termination or dissolution of Fetch Life Incorporated, any assets lawfully available for
distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal
Revenue Code, or the corresponding section of any future federal tax code, which organization or organizations have a
charitable purpose which, at least generally, includes a purpose similar to that of Fetch Life Incorporated. In the absence of
such, assets will be distributed to the federal government, or state or local government for a public purpose.
