ARTICLES OF INCORPORATION OF. LEGION OF THE SYSTEM AFFECTED, INC. (A Florida Not For Profit Corporation)



I, the undersigned incorporator, for the purpose of incorporating and organizing \widehat{a} corporation under the Florida Not For Profit Corporation Act (the "Act"), do hereby execute the following Articles of Incorporation, and certify as follows:

ARTICLE 1 NAME.

The name of the corporation shall be: LEGION OF THE SYSTEM AFFECTED, INC. (the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The initial principal place of business of the Corporation shall be 3948 3rd Street South. Jacksonville Beach, Florida 32250-5847.

ARTICLE III

MAILING ADDRESS

The initial mailing address of the Corporation shall be 3948 3rd Street South. Jacksonville Beach, Florida 32250-5847.

ARTICLE IV PURPOSES

The Corporation is not-for-profit and is organized and shall be operated 1. exclusively for religious, charitable, scientific, literary, or educational purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding provision of any future United States Internal Revenue Law (the "Code").

No part of the earnings of the Corporation shall inure to the benefit of any director 2 or officer of the Corporation, or to any other person (except that the Corporation may pay reasonable compensation for services rendered to or on behalf of the Corporation and make other payments and distributions in furtherance of one or more of its purposes), and no director or officer of the Corporation, or any other person shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. The Corporation shall pay no dividends.

3. The Corporation shall not participate, directly or indirectly, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Corporation shall not have the objectives nor engage in activities that would characterize it as an "action organization" as defined in Treasury Regulations.

4. Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Code.

6. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all the assets (if any) of the Corporation exclusively for the purposes of the Corporation to such organization or organizations, as the Board of Directors of the Corporation shall determine, that are organized and operated exclusively for religious, scientific, literary, educational, or charitable purposes and that qualify as an exempt organization or organizations under Section 501(c)(3) of the Code. Any of such assets (if any) not so disposed of shall be disposed of by a Court with appropriate jurisdiction, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operate exclusively for such purposes.
