Pursuant to the provisions of Sections 617.1401 of the Florida Statutes, the undersigned Florida not-for-profit corporation hereby adopts the following Articles of Dissolution:

**ARTICLE I
NAME OF CORPORATION**

The name of the corporation is LEGION OF THE SYSTEM AFFECTED, INC. (hereinafter referred to as the "Corporation").

**ARTICLE II
DATE OF FILING OF ARTICLES OF INCORPORATION**

The Articles of Incorporation of the Corporation were filed on August 28, 2019, and the Corporation was assigned file number N19000008999.

**ARTICLE III
CONDUCT OF AFFAIRS; DEBTS OF THE CORPORATION**

APPROVAL OF DISSOLUTION**


