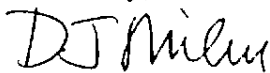

ARTICLES OF INCORPORATION  
OF  
ENDTIME BELIEVERS' WORLD ASSEMBLIES OF CHRIST, INC. (NOT FOR PROFIT)

The undersigned incorporator adopts these Articles of Incorporation pursuant to Florida Statutes Chapter 617.

1. Name. The name of this corporation is Endtime Believers' World Assemblies of Christ, Inc.

2. The street address of the original principal office of the Corporation, as well as its mailing address is 722 West 21<sup>st</sup> Street, Jacksonville, Florida 32206.

The purposes for which the Corporation is organized are to mentor and empower youth and community services of member churches, and all other lawful purposes and activities within the guidelines of the Corporation's charter and bylaws. The Corporation is organized and shall be operated exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. 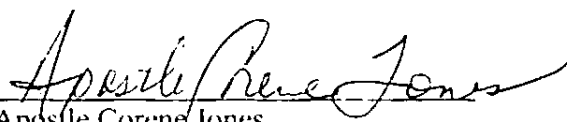

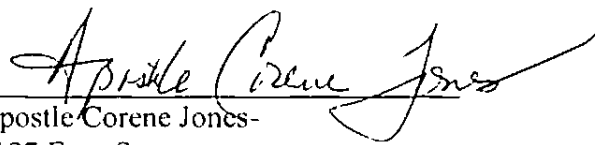
