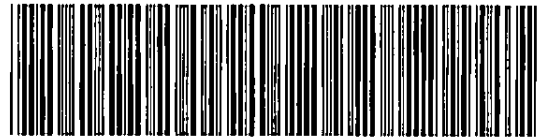

ARTICLE I

The name of this not for profit shall be Sota Can, Inc.

ARTICLE II

The initial mailing address and the principal office for the conduct of business of this non for profit is 3040 Leisure Place Sarasota, FL 34234. The officers of this non for profit may move the principal office to other addresses in Florida from time to time.

ARTICLE III

The purpose for which this not for profit has been organized is:

1. 
ARTICLE VIII
