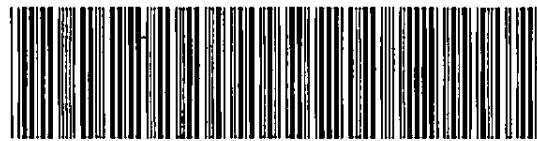

#### **Article 1 Name**

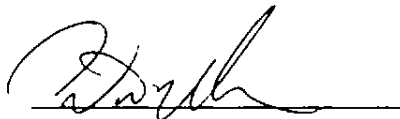

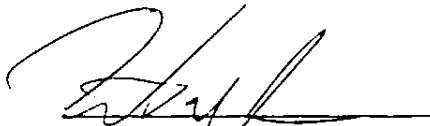

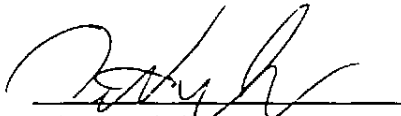
