The undersigned acknowledges and files in the office of the Department of State of Fiorida, for the purposes of forming a corporation not for profit in accordance with the laws of the State of Florida, these Articles of Incorporation:

ARTICLE I

The name of the corporation is Private Colleges and Universities of Florida, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and malling address of the corporation is 4200 54th Avenue South, St. Petersburg, Florida 33711, Attn: John Sullivan Admissions Office/PCUF.

ARTICLE III PURPOSE

The corporation is organized exclusively for charitable, religious, educational, or scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, as amended, and to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
