Purpose

Zion 3 Community Development Corporation was founded in May 2019 as a community outreach and economic development mechanism to expand the mission of New Mt. Zion AME Church in the City of Tallahassee, Florida. We are a separate, secular, not-for-profit organization guided by a diverse voluntary board of directors that bridges racial, economic, geographic, and religious boundaries. Our purpose is to alleviate the conditions of hunger, unemployment, underemployment, and homelessness in underserved areas. We will accomplish this vision by partnering with corporations to create affordable housing opportunities. In addition, we will develop and facilitate specialized training to all in need and by designing long-term approaches to achieving social and economic improvement at the grass roots level.

Zion 3 Community Development Corporation is formed exclusively for charitable, scientific, and educational purposes, within the meaning of section 501c-3 of the Internal Revenue Code, including, for such purposes, the making of distributions that qualify as exempt organizations under section 501c-3 or the Internal Revenue Code or the corresponding section of any future United States. Internal Revenue Law. Upon winding up and dissolution of the corporation after paying or adequately providing for debts and obligations of the corporation, the remaining assets shall be distributed for one or

providing for debts and obligations of the corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501c-3 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
