Pursuant to the provisions of section 617.0202, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation.

ARTICLE I

The name of the corporation shall be Florida Professional Association of Staffing Specialists, Inc. (the "Corporation").

ARTICLE II

The street address of the initial principal office of the Corporation shall be 9385 N 56th Street, Temple Terrace, Florida 33617. The mailing address of the Corporation shall be 111 S Glen Arven Avenue, Temple Terrace, Florida 33617.

ARTICLE III

This corporation was specifically created as an educational organization and social club with members bound together by the common objective of networking opportunities for educational professionals that work with special needs students. We are a professional association to allow for statewide networking and professional development.

The Corporation shall also be authorized to engage in and transact business within and without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article I hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not

participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
