Articles of Incorporation Upper Gulf Coast FL, Inc. Other Provisions

- I. <u>Purpose</u>: This Corporation is organized and shall be administered and operated exclusively to connect women to learn, play, and enjoy the game of golf.
- II. <u>Membership</u>: The Corporation shall have voting members as set forth in the Corporation's Bylaws.
- III. <u>Private Inurement</u>: No part of the net income of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the Corporation's purposes.
- IV. <u>Tax Restrictions</u>: Notwithstanding any other provision of the Articles of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(6) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
- V. <u>Dissolution</u>: Upon the dissolution of the Corporation, the winding up of its affairs, or the termination of the Affiliation Agreement with Executive Women's Golf Association, Inc. d/b/a LPGA Amateur Golf Association ("EWGA"), the assets of the Corporation shall be distributed exclusively to EWGA, which is exempt from Federal tax under §501(c)(6) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
