**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

Pursuant to Sections 617.1001 and 617.1002 of the Florida Not For Profit Corporation Act, **BEACH PARK WOMEN'S CLUB, INC.**, a Florida not-for-profit corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **BEACH PARK WOMEN'S CLUB, INC.**
2. The document number of the Corporation is N19000009798, and the effective date of the filing of the Articles of Incorporation of the Corporation with the Florida Department of State was September 17, 2019.
3. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety as follows:

ARTICLE I: The name of the Corporation is:


NEIGHBORHOOD WOMEN'S CLUB, INC.
