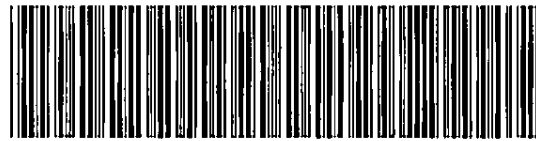

We are amending Article III.
