

Articles of Incorporation of

The Christian Mission US, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: The Christian Mission is a faith based ministry that carries a great passion and resolve to help those previously incarcerated to get truly established into society. We believe, that at the core of every man's heart is a desire for their life to have meaning to belong, to be loved and to love. One of the greatest challenges in our society today is to find men who are true role models in their love for God and who share it with the next generation. The reality is, that as goes the family so goes a nation and men are responsible to lead that charge. Our hope is to see men rise up again in our nation, as men of faith who take an active part in working to make it great. We desire to take those who were once a statistic and a burden to society and to see them radically changed and in turn become a great blessing.

To that endeavor the Christian Mission has a plan to help those who were even fatherless to become fathers and mentors themselves. To share with them the heart of our Heavenly Father in tangible, meaningful and life altering ways. It is well known and documented of the challenges that a man will face trying to get integrated back into society upon being released from prison, but it is even more difficult if that man has spent more than 2 years in the penal system. For those former prisoners who have the resolve and the fortitude it will take an average of three years to make the adjustment.

The Christian Mission has put together a comprehensive 3 year program that will help a man be equipped in a wholistic way to thrive as a man and to be a contributor to society.

Our plan can be seen in the following steps:

- 1. Transportation from prison
- 2. Give them a place to call home
- 3. Provide a one bedroom furnished apartment
- 4. They will have an address to receive mail
- 5. A community phone to speak with family/job interviews
- 6. Healthcare facility for medical needs
- 7. Food will be provided until employee

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth

herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
