ARTICLE III : PURPOSE

The purpose for which the corporation is organized is:

1. To preserve and promote Sikh religious, cultural and social values & heritage within the Sikh community in USA and FL.
2. To facilitate involvement of the members of the Association into the community, through religious, charitable, educational and cultural events with the purpose of promoting unity, understanding and friendship amongst the members of the association and in the community.
3. The corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the activities or the net earnings will unfairly benefit any director, officer, or other private person.
4. No part of the activities of the corporation shall be for any political campaign on behalf of or in opposition to any candidate for public office or in activities that in themselves are not in furtherance of one or more exempt purposes.

ARTICLE IV : Appointment of Directors

The manner in which Directors are appointed or elected is by Nomination.

ARTICLE VIII: Dissolution

Upon dissolution of the organization, Board of Directors/Officers shall, after paying all the liabilities, dispose off the assets and income of the corporation for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the Federal government or to a state or local government for a public purpose.

ARTICLE IX: Membership

1) Individuals, at least 18 years of age, from a Sikh Heritage & willing to contribute towards the objectives of the organization can become members of the Sikh Youth Association of South Florida Inc.

2) Members in good standing for a year shall be eligible to serve as Board Directors/Officers. The individuals will be nominated for Board Director /Officer positions on December 31st of each year.
