#### ARTICLE III: PURPOSE OF THE CORPORATION

The purpose of this corporation shall be to Crew Cares exists to provide comprehensive complete healthcare options for LGBTQA+ individuals without regard to race, color, national origin, residential status, religion, sex, gender identity, sexual orientation, age, or disability. Crew Cares is to provide care to the communities in which it serves without regard ability to pay or insurance status. To be active with the community, eliminating LGBTQA+ disparities, improve health concerns, reduce and effectively stop the spread of HIV/AIDS and STD's with cutting edge and compassionate care with prevention and treatment tools in stigma and judgement-free environment. Crew Cares shall always put our LGBTQA+ community's health and wellbeing first. We believe that a healthy and well educated and informed community is a successful and thriving community.

In the event that the corporation shall ever cease to adhere to its purposes as set forth herein all property, both real and personal, and other assets of the corporation shall revert and be distributed to another institution or organization of like purposes qualified under Section 501(c)(3) of the Internal Revenue Code consistent with the provision of Article nine (IX) of these Articles of Incorporation as now or hereafter amended.

### ARTICLE IX: DISSOLUTION OF CORPORATION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
