AMMENDMENT OF ARTICLE OF INCORPORATION FOR RECIBELO MINISTRIES INC

PURPOSE

The purpose for which the corporation is organized are:

- a.- The purpose for which Recibelo Ministries Inc is organized are exclusively religious, charitable, and/or educational within the meaning of Section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- b.- Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- c.- No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

AMMENDMENT II

OTHER PROVISIONS

Earnings/Dissolution: No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for the stated purpose of the corporation in such manner, or to one or more organizations which themselves are exempt as organizations described in Section 501©(3) and 170©(2) of the Internal Revenue Code of 1986 or corresponding Section of any future Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the
