**ARTICLES OF INCORPORATION
OF
ALPHA CYCLING, INC.**

The undersigned incorporator hereby forms a non-profit corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

ALPHA CYCLING, INC.

The address of the principal office of this corporation shall be 3839 NW Boca Raton Blvd., Suite 100, Boca Raton, Florida 33431, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

The business may engage or transact in any or all lawful activities or business consistent with the nature of the business set forth herein and permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

A. This Corporation is organized and operated exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This Corporation shall be a nonprofit corporation. The specific purpose of the organization is:

The nature of the business and the purposes to be conducted and promoted by Alpha Cycling, Inc. shall be for charitable, health and wellness education, and amateur athletic competition purposes and

it shall be nonprofit and nonpartisan; it shall benefit the public and community through cycling and athletic training, education, and awareness, including advocacy of good health, fundraising, cycling related events and related activities.

- B. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- C. No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.
- D. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of Sections 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

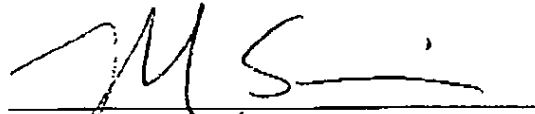
