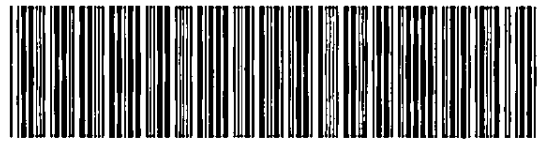

ARTICLE I.-NAME

The name of this corporation is C&C LEMONADE FACTORY, INC.

ARTICLE II.-PRINCIPAL PLACE OF BUSINESS

The principal place of business of the corporation is St. Petersburg, Pinellas County, Florida. The mailing address of the corporation is 5720 Central Avenue, St. Petersburg, FL 33707. The name and address of the incorporator of this corporation is Charles R. Gallagher III 5720 Central Avenue, St. Petersburg, FL 33707.


ARTICLE VIII.-AMENDMENTS
