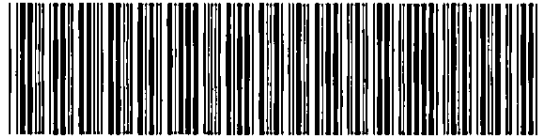

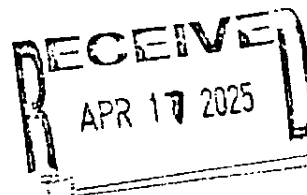

Plan of Distribution of Assets

DeBary Scholarship Foundation, Inc. will cease operations and dissolve effective March 31, 2025. Following is its plan of distribution of assets in accordance with its articles of incorporation, its bylaws, and the laws of the State of Florida and the United States.

**Assets**

DeBary Scholarship Foundation, Inc. holds a total of \$1791 cash. Of this total, \$35 will be used to file Articles of Dissolution with the State of Florida. The remaining assets total \$1756.

Prior to its date of dissolution, DeBary Scholarship Foundation, Inc. will transfer all of its remaining cash and cash equivalent assets to FUTURES Foundation for Volusia County Schools, a 501(c)(3) organization engaged in activities substantially similar to those of DeBary Scholarship Foundation, Inc.

DeBary Scholarship Foundation, Inc. holds no other assets upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, be returned, transferred, or conveyed in accordance with such requirements.

DeBary Scholarship Foundation, Inc. holds a small amount of stationery that is personalized to the organization and thus has no value outside of the organization. All such stationery will be discarded upon dissolution of the organization. DeBary Scholarship Foundation, Inc. holds a trivial amount of office supplies that will be discarded upon dissolution.

Aside from those described above, DeBary Scholarship Foundation, Inc. holds no other assets. No assets will be retained or transferred to any member of DeBary Scholarship Foundation, Inc., or any other entity.

**Liabilities**

All liabilities and obligations of DeBary Scholarship Foundation, Inc. have been paid and satisfied in full. DeBary Scholarship Foundation, Inc. has no existing liabilities.
