



#### **ARTICLE III - PURPOSE**

- 1. We Will Find a Cure Foundation, Inc.'s mission is a cancer-free future. Specific objectives of this organization shall be: a) to support cancer research and other institutions dedicated to improving the quality of life of cancer patients, survivors and their families; b) to promote awareness, inspire personal involvement and provide education about cancer, cancer-prevention & risk factors; c) to actively involve and encourage the contributions of young people by supporting, incorporating, and nurturing their creativity, passion, knowledge and leadership skills in our quest to cure cancer.
- 2. This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

# **ARTICLE VI - LIMITATIONS**

- 1. No substantial part of the activities of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of public office.
- 2. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

## **ARTICLE VII - DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
