Articles of Incorporation Of The  
**YOUTH UNDERESTIMATED CORPORATION**

**ARTICLE I**  
**NAME**

The name of this corporation shall be **Youth Underestimated Corporation**. The business of the corporation may be conducted as **Youth Underestimated Corporation** or **Youth Underestimated**.

**ARTICLE II**

**ARTICLE III**  
**PURPOSE**

**Youth Underestimated Corporation** is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

**Youth Underestimated Corporation** shall exist for the purpose of broadening the knowledge of the recruiting process, academic and NCAA requirements, tutoring, SAT/ACT preparations, as well as discipline on and off the field to all interested youth by providing free events within the community, schools, and social media outlets. **Youth Underestimated Corporation** plans to organize college visits, and other educational and physical activities to expose student athletes to life beyond high school.

**ARTICLE IV**  
**BOARD OF DIRECTORS**

**Youth Underestimated Corporation** Board of Directors shall consist of the President (and/or co-presidents), Vice-president, Administrative Officer, and Financial Officer. Board Directors shall be appointed by the President and/or current Board of Directors. **Youth Underestimated Corporation** shall be governed and appointed by its board of Directors. The Founding Directors of the corporation shall be the President, Vice-President, Administrative Officer, and Financial Officer.

**ARTICLE V**  
**NONPROFIT NATURE**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. **Youth Underestimated Corporation** shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
