

ARTICLES OF INCORPORATION FOR

A FLORIDA NOT-FOR-PROFIT ORGANIZATION

Articles of incorporation for **ASOCIACION DE CRITICOS Y CRONISTAS DE ARTES ESCENICAS DE MIAMI, INC.** a Florida not-for-profit organization, the undersigned incorporator to form a Florida Not-for-Profit Corporation, hereby adopts the following articles of incorporation:

ARTICLE I

The name of the not-for-profit Corporation is

ARTICLE III

The specific purpose for which the corporation is organized is:

ASOCIACION DE CRITICOS Y CRONISTAS DE ARTES ESCENICAS DE MIAMI, INC. is a non-profit organization that seeks to bring together the chroniclers, journalists and theatrical critics of Miami-Dade County with the following objectives:

To stimulate the quality in the performing arts and in the theatrical criticism in Spanish that are made in our city. To promote, mainly at the local level, the different theatrical manifestations that take place in the Hispanic sphere. To promote the dissemination and development of theatrical culture according to its various facets: At the artistic and creative level, promoting the professional development of the theater. At the academic and scientific level, promoting theater knowledge, research and dissemination of the historical, technical, aesthetic and analytical knowledge of local, national and international theater. At the cultural level, facilitating the circulation of information about the theater in Miami in all its facets, genres and stages of artistic development. At the level of diffusion and expansion, promoting, inside and outside of our community, the productions and the Miami theater players through digital platforms, audiovisual and printed media. To achieve these ends, ASOCIACION DE CRITICOS Y CRONISTAS DE ARTES ESCENICAS DE MIAMI, INC. will carry out a wide number of activities: Dissemination of critiques, reports and theatrical chronicles (visual and written) in established media and in publications that belong to the Association. Organization of courses, conferences, colloquiums, seminars, workshops and other similar activities related to the performing arts. Dissemination of scenic shows, always supporting artistic quality. Sponsoring theatrical and cultural research, books and compilations that gather and unite knowledge, which is now scattered about, of the theatrical history of Miami. Manage and award annual prizes and awards to the various artistic and professional individuals involve in the Spanish language theater.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable

compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. DISSOLUTION Upon the dissolution of the not-for-profit organization, assets shall be distributed to the federal Government for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future code, or shall be distributed to the Federal Government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed by a Court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
