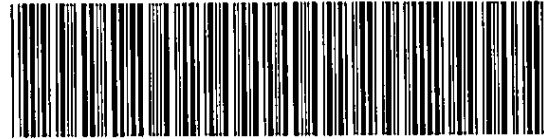

ARTICLES OF INCORPORATION

of

Point of Grace Christian, INC.

The undersigned subscriber to these Articles of Incorporation, being a natural persons to contract, hereby forms a corporation not for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: Point of Grace Christian, INC.

ARTICLE II. PRINCIPAL OFFICE

The initial post office address of the principal place of business of this corporation in the State of Florida is: 920 N. Courtney Rd. Perry, FL 32347. The Board of Directors may from time to time move the principal place of business to any other address in Florida.

ARTICLE III. PURPOSE

The corporation is a not for profit corporation. The purposes for which the corporation is organized are:

- A. The Corporation is organized exclusively for charitable, religious, and education purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B. Such purposes shall include, but not limited to, delivering a

- C. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment distributions in furtherance of the purposes set forth in this Article III.

ARTICLE IV. MANNER OF ELECTION

This corporation shall have 7 director(s), initially. The number of directors may be increased or decreased from time to time by laws adopted by the stockholders. The method of election of the directors is stated in the Bylaws of the corporation.

Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
